1. <u>ENVIRONMENTAL WEED CONTROL REBATE UPDATE</u>

With reference to a report concerning the Environmental Weed Control Rebate (EWCR). This report is proposing that Council cease providing the EWCR.

RECOMMENDATION

That the Interim Administrator of Ipswich City Council resolve:

That the Environmental Weed Control Rebate be discontinued from the 1 July 2019 and that the Nature Conservation Grants program continue to provide funding support for landholders engaged in strategic conservation management in accordance with the *Ipswich Enviroplan Program and Levy Policy*.

2. NATURE CONSERVATION GRANTS REVIEW

With reference to a report concerning the Nature Conservation Grants Program Review. The Nature Conservation Grants (NCG) is one of the on-ground delivery mechanisms under the Nature Conservation Strategy 2015, Waterway Health Strategy 2009 and *Ipswich Enviroplan Program and Levy Policy*.

A review of the Nature Conservation Grants program guidelines and assessment criteria has been undertaken to provide consistency with other Council grant programs and ensure applicants have access to a transparent and streamlined grant application process.

RECOMMENDATION

That the Interim Administrator of Ipswich City Council resolve:

That the review and update of the Nature Conservation Grant Guidelines and assessment criteria as outlined in the report by the Program Officer (Natural Environment) dated 1 April 2019, are to take effect from 1 July 2019.

SUBJECT: ENVIRONMENTAL WEED CONTROL REBATE UPDATE

INTRODUCTION

This is a report concerning the Environmental Weed Control Rebate (EWCR). This report is proposing that Council cease providing the EWCR.

RELATED PARTIES

All landholders in the Ipswich City Council area, including residents, businesses and non-for profit organisations who have previously received the EWCR, or would potentially apply for the EWCR in the future.

ADVANCE IPSWICH THEME LINKAGE

Caring for the environment

PURPOSE OF REPORT/BACKGROUND

The Environmental Weed Control Program (the EWCR) was introduced in the late 1990's. Funded by the Ipswich Enviroplan Levy, the EWCR was introduced to support landholders across the city with removal of environmental weeds from their land that threaten the broader City's natural areas. The EWCR provides landholders with a rebate on weed removal, to the value of \$600 - \$1,000 per rates assessment number, per financial year. The rebate covers up to 50% of the cost of contractor works or herbicide purchase up to the eligible rebate amount.

Since its introduction, the EWCR has predominately provided support for residents with removal of large single trees (e.g. Chinese elms) located in urban areas. This often has poor alignment with the strategic objectives of the Nature Conservation Strategy and the outcomes of the Enviroplan Policy. Since July 2015, approximately \$316,500 in rebates have been distributed. The budget allocation over this period was \$120,000.

There are existing incentives that support landholders with weed removal activities within the Landholder Partnerships Program, including the Nature Conservation Grants. These incentives are available to Voluntary Conservation Agreement landholders who have a demonstrated commitment to conservation on their property and reside in strategic areas as identified in the Nature Conservation Strategy.

Landholders can receive up to \$6,000 per financial year in grant funds to go towards conservation works, which includes weed removal activities. The Nature Conservation Grant supports best-practice land management to achieve a more holistic and sustainable approach to land management, in comparison to the EWCR. As landholders with Voluntary Conservation Agreements have a strong commitment to conservation on their property, Ipswich City Council's investment is secure and utilised in an efficient and effective manner.

It is proposed that Council discontinues the EWCR from the 1 July 2019. This will allow the funds identified in the 2019-2020 operational budget to be reallocated to the Nature Conservation Grants; increasing the funds available for landholders within strategic areas which will achieve improved ecological outcomes, and improved use of Enviroplan funds. This is in line with the *Ipswich Enviroplan Program and Levy Policy* (Attachment 1.).

RESOURCE IMPLICATIONS

The removal of the Environmental Weed Control Rebate will redirect Enviroplan funding into other conservation programs, therefore, there will be no net budget implications. The removal of the EWCR will reduce the workload of staff from the Applications team (Finance and Corporate Services Department) who assess the EWCR applications, and the Program Officers (Natural Environment) who are the program owners and provide advice and guidance on issues pertaining to Rebate applications. It has been estimated that the proposed change will result in additional staff time of 0.2FTE which support greater efficiency and effectiveness in delivering the Conservation Program.

RISK MANAGEMENT IMPLICATIONS

As over 1000 applications for the EWCR have been received since the 2015-2016 Financial Year, the risk of implementing the recommendations proposed in this report is community concern and reputational damage. Various residents have utilised this rebate to fund their weed removal projects for a number of years and would potentially be dissatisfied with the decision to remove this incentive from the Landholder Partnerships Program. To mitigate this risk a factsheet will be developed and made available to the customer service centre to provide to customers explaining the amendments to the EWCR and other potential funding avenues through Council's Landholder Partnership Program. It will also detail the clear alignment required between Council grants and rebates and the *Ipswich Enviroplan Program and Levy Policy*.

The risk of not implementing the recommendations proposed in the report is the risk of poor alignment with the relevant Policy and Nature Conservation Strategy, continued and unmitigated over-budget expenditure of the EWCR annual budget, and inefficient use of Enviroplan funds.

LEGAL/POLICY BASIS

This report and its recommendations are consistent with the following legislative provisions: *Local Government Act 2009*

COMMUNITY AND OTHER CONSULTATION

Consultation occurred between the relevant officers within the Works, Parks and Recreation Department and the Applications Team on the proposed changes to the Landholder Partnership Program.

Some informal consultation has been undertaken between the Program Officers (Natural Environment) and the community through the Landholder Partnerships Program during meetings and site visits.

CONCLUSION

The Environmental Weed Control Rebate has distributed funds to landholders in nonstrategic areas within Ipswich, which provides minimal ecological benefits at a large cost to Council. This report proposes that the EWCR is discontinued and funds for the EWCR are reinvested into other programs within the Landholder Partnerships Program, including the Nature Conservation Grants.



1.1.4 Policy Outcomes The outcomes of the application of this policy are:

- create a healthy and vibrant natural environment, highly valued by, and connected to the

1.3 Policy Statement

- Council recognises that identifying, protecting and maintaining the health of vital ecosystems and natural environmental values as a priority in creating a sustainable and liveable community.
- The levy provides funding for Enviroplan projects and initiatives, associated with implementation of council's strategies/plans.
- These projects and initiatives directly address the protection and enhancement of Ipswich's natural environmental values including, but not limited to:
 - o Significant habitat for flora & fauna
 - Vegetation communities

o Aboriginal Cultural Landscape values and regional landscape corridors

1.4 Scope:

The policy:

- provides direction for the allocation of funds and management of the levy through Enviroplan's projects and initiatives that complement council's core environmental activities; and
- applies to all Council endorsed Enviroplan projects and initiatives, that are funded and supported, wholly or partly with revenue from the levy.

1.5 Guiding Principles:

This policy is guided by the following principles:

- Transparent, systematic and practical delivery;
- Conservation, improvement and adaptive management;
- Collaborative partnerships with stakeholders; and
- Council's Nature Conservation Strategy.

1.6 Distribution of Environment Levy Revenue to Enviroplan Program:

- The annual levy charge per rateable property is reviewed and determined by council as part of adopting its annual revenue statement.
- All revenue collected including any revenue raised through approved levy business activities is held and accounted for separately from Council's general revenue.
- In addition to revenue generated from property charges, levy funding may also be generated through approved levy business activities which may include grants, fund matching, fees, payments, penalty charges, donations and sponsorships.
- All revenue collected including any revenue raised through approved environment levy business activities is held and accounted for separately from Council's general revenue.
- Levy revenue should not be available at any time for expenditure as general revenue.
- Levy can be used in the development of the annual Ipswich Enviroplan Program.
- The levy can only be expended with the Ipswich local government area.
- The amount of environment levy revenue allocated to each of the four primary Ipswich Enviroplan Program funding themes is determined based on an assessment of annual priorities and emerging needs and endorsed by council.
- Expenditure of the levy for enhancing core environmental values is guided by the Nature Conservation Strategy which is developed based on evidence based research and studies using qualified independent specialists, and reviewed every 5 years.
- Any unspent funds associated with each of the four funding themes is returned to the Enviroplan Levy fund.

1.6.1 Enviroplan Program

- The Enviroplan Program (the program) consists of projects and initiatives within four strategic themes that deliver outcomes to protect and enhance the health of Ipswich's natural environmental:
 - o Acquisition of significant nature conservation land
 - o Community nature conservation partnerships and support
 - o Nature conservation planning
 - Embellishment, capital and operational management investment within the Natural Area Estate

1.6.2 Enviroplan Program Funding Themes

- The program is developed and reviewed annually, in consultation with Council, preceding budget preparations.
- The four program funding themes are:

(A): Acquisition of significant nature conservation land

• Protect and enhance the city's and region's environmental values and ecological processes by expanding nature conservation areas through a strategic approach to acquiring land.

(B): Community nature conservation partnerships and support

• Protect, manage and enhance nature conservation through building community capacity and effective partnerships with stakeholders.

(C): Nature Conservation Planning

• Create a resilient natural environment and lessen the impact of detrimental processes through city-wide systematic planning, management and research activities/projects.

<u>(D): Embellishment, Capital and Operational Management Investment Within the Natural</u> <u>Area Estate</u>

- Protect, manage and enhance the Natural Area Estate (the Estate) through the application of sound environmental management principles – consistent with the Conservation Estates and Reserves Management Policy.
- Funding supports Council's nominated environmental operational management activities within the Estate in accordance with their strategies, plans and service levels.

1.6.3 Enviroplan Program and levy reporting:

- A report is tabled with Council on an annual basis to report on financial year performance/achievements on program delivery.
- Core environmental values are monitored and measurement on a 5-year basis using independent qualified scientists.

Ipswich POLICY

1.6.4 Enviroplan Review

The Enviroplan levy will be reviewed after 3 years and after assessing the balance of acquisitions and enhancements.

The review will be done in consultation with the Environment Committee.


1.7 Roles and responsibilities:

- Council will review the environment levy charge, Policy and Program annually.
- The implementation of the Enviroplan Program and Policy is integrated across the business area of Works Parks and Recreation Department, and the following key roles are responsible for specifics aspects:

Role	Responsibility
Chief Operating Officer (Works Parks and Recreation)	For the overall coordination of the Enviroplan Program and levy including policy guidance to Council, coordination of corporate and other reporting requirements, the preparation of a five year program. Coordinates decision making and recommends the Nature Conservation Strategy and other studies to Council. Ensure consultation with the Environment Committee is undertaken as part of the review of the Enviroplan levy.
Sport, Recreation and Natural Resources Manager	Ensure that the Enviroplan Program and associated projects are delivered in accordance with the policy and funds are applied accordingly Ensure the delivery of the Nature Conservation Strategy.
City Maintenance Manager	Ensure that delivery of maintenance and management within the Natural Area Estate is delivered in accordance with the policy and funds applied accordingly
Business Accounting and Asset Manager	Support with the provision of financial reporting and models.

1.8 Definitions:

- Aboriginal Cultural Heritage: is anything that is (in accordance with the Aboriginal Cultural Heritage Act 2003)
 - (a) a significant Aboriginal area in Queensland; or
 - (b) a significant Aboriginal object; or





(c) evidence, of archaeological or historic significance, of Aboriginal occupation of an area of Queensland.

- Aboriginal Cultural Landscape Feature: is a feature valued by an Aboriginal group (or groups) because of their long and complex relationship with that land. Features include, but are not limited to rock outcrops, caves, areas of biogeographical significance, waterholes, springs, particular types of vegetation and some hill and mound formations. Aboriginal cultural landscape emphasises the landscape-scale of history and the connectivity between people, places and heritage items. It recognises that the present landscape is the product of long-term and complex relationships between people and the environment.
- **Embellishment:** Additions added to improve the visitor experience or management within Natural Area Estates.
- Environment Levy: refers to a levy (charge) raised by Ipswich City Council (in accordance with the Queensland *Local Government Act 2009*), on all rateable properties within its jurisdiction, in order to assist with environmental protection and management.
- Natural Area Estate: Collection of Council's public open space lands comprising Conservation Estates and Conservation Reserves (excluding local bushland reserves) that are specifically managed by Council for their nature conservation values and ecological importance.
- Nature-Based Recreation: Activities that are dependent on the natural environment; have an
 appreciation of nature as a motivational factor; do not require substantial modification to the
 natural environment; and are environmentally sustainable.
- Nature Conservation Values: A tool used to classify prioritise conservation efforts for ecosystems, habitat and their constituent parts such as plant and animal species.
- **Operational Management:** Activity concerned with planning, organising and delivering habitat restoration works.
- Significant Nature Conservation Land: Defined areas that contain ecosystems and habitat of highest priority for protection and maintenance efforts.
- Terrestrial: relating to land based aspects rather than water and air

INTRODUCTION

A review of the Nature Conservation Grants program guidelines and assessment criteria has been undertaken to provide consistency with other Council grant programs and ensure applicants have access to a transparent and streamlined grant application process.

RELATED PARTIES

Private landholders registered with a Voluntary Conservation Agreement who are eligible to apply for the NCG are the major stakeholders.

ADVANCE IPSWICH THEME LINKAGE

Caring for the environment

PURPOSE OF REPORT/BACKGROUND

The Nature Conservation Grants Program is funded via Council's EnviroPlan Levy to assist landowners who have a Voluntary Conservation or Partnering Agreement registered with Council for their property. It is an extension of the Conservation Partnerships Program aiming to provide financial support for projects with direct short and long term environmental benefits on private land.

On-ground activities that are supported include the rehabilitation of degraded conservation landscapes, protection and improvement of habitat and biodiversity, and improvement of climate resilience of Ipswich's natural environment.

Objectives of the Nature Conservation Grants are to:

• Build a resilient natural environment

- Improve and maintain biodiversity
- Invest in nature conservation, and
- Promote community participation and capacity building.

A review of the grants program revealed a number of areas to be improved to support the on-going success of the program. These included:

- improvements to the availability and clarity of the grant guidelines
- removing Program Officers from the assessment process to allow them to provide up-front support to landholders with applications
- providing separate assessment criteria for terrestrial and waterway projects to give them an equal platform for assessment, as the previous criteria were heavily weighted towards terrestrial projects
- improved scoring and weighting of the assessment criteria

Identified issues and proposed solutions are referred to in table 1.

Table 1 Identified issues and proposed solutions

RESOURCE IMPLICATIONS

The 2018–2019 budget was underspent by \$56,741 as a result of criteria with limited consideration for waterway values. Based on the potential solutions, the risk of underspending funds is low as all applicants will be given a fair assessment.

RISK MANAGEMENT IMPLICATIONS

The risks associated with not approving the recommendations will have implications on the transparency of grant criteria and landholder expectations as well as meeting Council's obligations to support the extension delivery of the Conservation Partnerships Program. Separating assessment criteria to capture waterway values reduces inconsistency associated with grant assessments. The proposed scoring and weighting method provides rigour around a process of elimination as a result of budget constraints or project quality.

LEGAL/POLICY BASIS

This report and its recommendations are consistent with the following legislative provisions: *Local Government Act 2009*

COMMUNITY AND OTHER CONSULTATION

Voluntary Conservation Agreement partners have been consulted with during the review process and have been made aware of future changes to the NCG. This consultation has occurred via the monthly Partnerships update and through personal communications.

Relevant staff have been consulted with for strategic and subject matter guidance.

CONCLUSION

The Nature Conservation Grants program has been reviewed to ensure a more transparent and streamlined process, and alignment with Council's relevant strategies and policy outcomes. The review identified solutions which will enable a more efficient approach and provide accountability for Grant applicants and assessors.

The assessment criteria will be made visible to conservation partners to allow for an easier assessment of applications and fair justification or feedback to applicants. The separation of assessment criteria will ensure equal opportunities for all applicants applying for different project outcomes.

Guidelines

Grants program overview

The Nature Conservation Grants Program (NCG) aims to support tangible conservation outcomes on private land. The NCG is funded by Ipswich City Council's (Council) EnviroPlan to assist landowners who have an existing Voluntary Conservation or Historical Agreement registered on their property. The NCG provides partnering landowners with an opportunity to undertake on-ground activities to rehabilitate degraded landscapes, protect and improve habitat and biodiversity and improve the climate resilience of Ipswich's natural environment.

Objectives

- Build a resilient natural environment
- Improve and maintain biodiversity
- Invest in nature conservation
- Promote community participation and capacity building

Timeframe

Applications will open on 1 July and close on 31 July each year. Applications must be received by close of business on the identified closure date.

Recipients

This is a competitive grant category open to landowners who have Voluntary Conservation Agreement on their properties whose project meets the eligibility criteria and does not fall within any of the exclusions.

Funding Range

Applicants are eligible to apply for a maximum of up to \$6,000 (excluding GST) per project per funding round.

Funding Available

The total funding available for the Nature Conservation Grants each year is subject to variation,dependingonCouncil'sannualbudgetallocation.

Applicants may apply under one of the following categories;

Outcome 1– sustainable natural resource management with primarily terrestrial outcomes. Outcome 2 – sustainable natural resource management with primarily waterway outcomes.

Eligibility Criteria

To be eligible for funding under the NCG, landholders must:

 have a Voluntary Conservation Agreement (VCA) which includes: Bushland Conservation Agreement (BCA), Nature Conservation Agreement (NCA), Koala Conservation Agreement (KCA) or Waterway Conservation Agreement (WCA)

OR

✓ have an historical conservation agreement including a Partnering Agreement (PA), Vegetation Retention Agreement (VRA), Rural Conservation Agreement (RCA) or Nature Corridors Conservation Agreement (NCC)

Two or more eligible landholders can work in partnership on a single project to undertake on-ground activities across two or more properties. Partnership applications must be of a joint nature, where one applicant submits the application with a letter of commitment from the second landholder.

A representative acting on behalf of an eligible applicant may submit an application with a letter of approval from the eligible applicant.

Eligible Projects/Activities Examples

Projects which have an environmental benefit include but are not limited to;

Outcome 1 - Terrestrial projects/activities

- ✓ control invasive plants
- ✓ control pest animals
- ✓ install fauna-friendly fencing to restrict stock access to ecologically significant areas
- ✓ modify existing fencing to upgrade it to be more wildlife friendly
- ✓ increase the area and connectivity of native vegetation by planting native plant species (revegetation) and allowing plants to naturally grow (regeneration)
- ✓ use of fire for ecological purposes
- ✓ native fauna monitoring
- Outcome 2 Waterway projects/activities
 - ✓ install off-stream watering points to restrict stock access to significant waterways
 - ✓ control invasive plants
 - ✓ control erosion and minimises sediment runoff
 - ✓ riparian restoration by planting native plant species along waterways to enhance the riparian buffer

Note:

Other projects/activities may be considered eligible after consultation with your Program Officer. Applicants should consider discussing proposed projects with their Program Officer prior to submission. A site visit may be arranged to discuss these activities with the landholder.

Exclusions

The following will not be funded:

- × a landholder who does not have an existing VCA or Historical Conservation agreement
- * an applicant who has not satisfactorily acquitted a previous NCG
- projects that do not have a primary aim of improving environmental values of an area (e.g. landscaping and planting of ornamental plants)
- × activities that require planning approval
- × activities that contravene any local, state or commonwealth legislation or policy
- × natural resource management activities in orchards and crops
- * natural resource management in the following domestic areas; gardens, lawns and around dwellings. Such activities include; enclosure for animals, property rates payments, approval fees, upgrades, maintenance or repairs to property infrastructure such as dams, weirs, drains, driveways, roads, boardwalks and formal paths and control of pest plant species that landholders are legally required to report to an appropriate authorised officer
- hard engineering solutions for waterway restoration

Grant Funding Principles

Ipswich City Council applies the following principles when providing support through its Nature Conservation Grants Program:

- Encouraging best practices conserving natural resources on private land
- Improving and maintaining the condition and status of national, state and local matters of environmental significance
- · Recognising nature conservation as a major feature of good governance for the City
- Providing continuous communication and engagement with the Ipswich community in regards to nature conservation and environmental values in Ipswich
- Valuing local collaborations and partnerships
- Valuing the social, economic and environmental sustainability of our City

In addition, Council is committed to the efficient and effective delivery of the Nature Conservation Grants Program and transparency and accountability in decision making.

Grant Funding Approval Process

Final decisions and approval of successful applications are made by Council at a designated Council meeting.

All applications will be assessed in two parts and is reflective of the category chosen to apply for. Part A assesses the strategic alignment of the project / activity and is a desktop assessment completed by Council Officers in SRNR.

Part B assesses the value of the project. Both Parts are assessed by an assessment panel made up of at least three (3) Council Officers with expertise in natural area management or similar.

Terms and Conditions That Apply to Successful Applicants

Successful applicants will receive the approved funding from Council subject to the following terms and conditions:

- The applicants proposed project must be completed within 12 months
- The applicant will be required to enter into a funding agreement which details all grant conditions and agreed outcomes. This must be signed before grant funds are issued
- Applicants are required to complete an acquittal at the completion of the funding period. If Council grant funds are not spent, all remaining funds must be returned to Council
- Council may make funding conditional on other specific conditions being met

Grant Acquittal

To ensure appropriate accountability by grant recipients, all funding provided by Council will require a report and financial acquittal, outlining the use of the funds (including proof of expenditure) and the achieved outcomes of the project/activity.

Landowners who have not satisfactorily acquitted Council funds within the appropriate timeframe agreed by Council will be deemed ineligible for Council funding or in-kind assistance for 12 months from the acquittal due date.

All applicants must:

- ✓ answer all application questions on the online SmartyGrants form
- clearly demonstrate how the project outcomes address the selection criteria in Part A for Outcome 1 or Outcome 2 and Part B for both Outcome 1 and Outcome 2.

Please note: Co-contribution is your contribution to the project. This can either be your own financial or labour contribution. The current wage rate for volunteers in Queensland is \$40.35. Your labour can be charged at this rate. (*https://volunteeringqld.org.au/volunteers*)

Application process

Applications must be made using the appropriate online application forms. Additional information can be attached as required.

Applicants will be notified via email of the outcome of their application.

Incomplete applications will not be considered for funding. This includes applications <u>without</u> essential documentation.



EXECUTIVE SUMMARY

This is a report concerning the delegation of Council's powers under the *Water Supply* (*Safety and Reliability*) *Act 2008* (the "Act").

RECOMMENDATION/S

That pursuant to section 257(1) of the *Local Government Act 2009*, Council delegate to the Chief Executive Officer, Council's powers in its capacity as a local government under the *Water Supply (Safety and Reliability) Act 2008* and any subordinate legislation under that Act.

Conditions:

This delegation is subject to the following conditions:

Whenever this power is exercised, a record of the exercise of the power shall be made in writing at the time of exercising such power, and a copy thereof shall be kept in such format as determined from time to time by the CEO.

RELATED PARTIES

There are no identified related parties.

ADVANCE IPSWICH THEME LINKAGE

Listening, leading and financial management

PURPOSE OF REPORT/BACKGROUND

The *Water Supply (Safety and Reliability) Act 2008* provides that the owner of a referable dam must have an approved Emergency Action Plan (EAP) and that the owner of the dam must give a copy of the EAP to each local government before giving it to the Chief Executive of the Act.

In light of Council's renewed focus on governance, legal advice was sought to determine an approach to issuance of this notice. Based on this advice and the principles of good governance it is determined that a formal delegation be sought in order to issue the formal notice.

Under section 257(1) of the Local Government Act 2009, a local government may, by resolution, delegate powers under the Local Government Act or another Act or to the Chief Executive Officer. To enable Council to continue exercising powers relating to the assessment of an EAP for consistency with its disaster management plan and providing a formal notice and/or written response, it is requested that these powers be delegated to the CEO.

CONCLUSION

For reasons of operational efficiency, Council should delegate to the CEO the powers under Water Supply (Safety and Reliability) Act 2008. It is recommended that Council consider and adopt the delegation to the CEO outlined in the recommendations.
