#### 1. <u>CONFIRMATION OF MINUTES OF THE COMMUNITY, CULTURE, ARTS AND SPORT</u> <u>COMMITTEE NO. 2021(02) OF 11 MARCH 2021</u>

#### RECOMMENDATION

That the Minutes of the Meeting held on 11 March 2021 be confirmed.

#### **OFFICERS' REPORTS**

#### 2. \*\*<u>PROCUREMENT: LIBRARY COLLECTION RESOURCES</u>

This is a report concerning the procurement of the ongoing supply of physical library collection resources including print and audio-visual resources, and the relevant processing required for shelf-readiness of library collection resources for all Ipswich Libraries under Local Buy Pre-Qualified Supplier arrangement 'Library Resources (Goods and Services) LB284'.

The report recommends that pursuant to section 234 of the *Local Government Regulation 2012* (Regulation), Council utilise LGA Arrangement "Library Resources (Goods and Services) LB284" by Local Buy Pty Ltd for the provision of physical library collection resources (Council reference 15900), with James Bennett Pty Limited (Supplier) who is a party to the LGA Arrangement.

The cost of the engagement for the provision and processing of physical library collection resources is estimated to be \$1,245,500 (ex GST) per annum, or \$4,982,000 (ex GST) for the contract term, including options. This estimate is based on current spend and anticipated future budgets and resource requirements.

#### RECOMMENDATION

A. That pursuant to section 234 of the *Local Government Regulation 2012* (Regulation),
 Council utilise LGA Arrangement "Library Resources (Goods and Services) LB284" by Local Buy Pty Ltd for the provision of physical library collection resources (Council reference)

15900), with James Bennett Pty Limited (Supplier) who is a party to the LGA Arrangement, as detailed in this report by the Goods and Services Category Specialist dated 25 March 2021.

- B. That under the LGA Arrangement with the Supplier, the estimated purchase price is \$4,982,000 excluding GST over the entire term, the end date of the initial term being 30 June 2023, with the option to extend at the discretion of Local Buy Pty Ltd for an additional two (2) twelve (12) month terms.
- C. That Council may enter into ancillary contractual arrangements with the Supplier, as allowed by the LGA Arrangement.
- D. That pursuant to section 257(1)(b) of the *Local Government Act 2009*, Council delegate to the Chief Executive Officer the power to take "*contractual action*" pursuant to section 238 of the Regulation, in order to implement Council's decision, however the delegation does not allow for options for extension to be offered in any ancillary contractual arrangements other than those already allowed for under the LGA Arrangement.

# 3. <u>INVESTIGATE A NON-EXCLUSIVE ARRANGEMENT WITH PLAYGROUP QUEENSLAND</u> <u>AND ADDITIONAL USES FOR THE FACILITY AT 56 HAROLD SUMMERVILLES ROAD,</u> <u>KARALEE</u>

This is a report addressing the request by Council concerning the further investigation by Council officers into a non-exclusive arrangement with Playgroup Queensland and additional uses for the facility at 56 Harold Summervilles Road, Karalee described as Lease D in Lot 1 on RP170788 on SP216939.

#### RECOMMENDATION

- A. That Council receive and note the contents of this report.
- B. That Council enter into a Lease with Playgroup Queensland Ltd as per the recommendations from the report presented at the Governance and Transparency Committee No. 2020(03) dated 15 October, 2020 as outlined Recommendations C, D and E below:
- C. That Council resolve pursuant to the *Local Government Regulation 2012* (the Regulation) that the exception under sections 236(1)(b)(ii) and 236(2) of the Regulation apply to the disposal of the leasehold interest located over part of 56 Harold Summervilles Road, Karalee described as Lease D on Lot 1 on RP170788 on SP216939 ("the land"), by way of a lease between Council and Playgroup Queensland Ltd for a consideration.
- D. That Council enter into a Lease with Playgroup Queensland Ltd ("the lessee") for a five (5) year term.

E. That under s257 of the *Local Government Act 2009*, Council resolve to delegate the power to the Chief Executive Officer to authorise and negotiate the terms of the Lease to be executed by Council with Playgroup Queensland Ltd and to do any other acts necessary to implement Council's decision.

#### 4. MAJOR COMMUNITY EVENT SPONSORSHIP - IPSWICH SHOW

This is a report concerning the Major Community Event Sponsorship application by Ipswich Show Society for support of the Ipswich Show to be held in May 2021 at Ipswich Showgrounds.

The application is for a cash sponsorship of \$40,000 along with in-kind support through the provision of rubbish bins and removal and a range of council services.

#### RECOMMENDATION

That Ipswich Show Society receive \$35,000 ex GST cash support for the 2021 Ipswich Show.

#### 5. QUARTERLY EVENT SPONSORSHIP AND TICKET ALLOCATION REPORT

This is a report concerning event sponsorships approved and ticket allocations made in the period January to March 2021. This quarterly report to the Community, Culture, Arts and Sport Committee is required under the Event Sponsorship Policy.

#### **RECOMMENDATION**

That Council note that the following event sponsorships were approved in the January – March 2021 period:

- A. Event Sponsorships over \$15,000 ex GST endorsed by council:
  - 1. Ipswich Turf Club \$20,000 ex GST financial support and additional in-kind support of star pickets and covers, rammer and rolls of barrier mesh (all to be returned at no cost to council) for the 2021 Ipswich Cup.
  - 2. Limestone Events Inc. \$10,000 ex GST cash support and the following in-kind support valued at \$12,000 ex GST for The Gathering:
    - Inclusion of a two page feature in Council's seasonal Quarterly Guide;
    - Inclusion on the Council funded Mt Ommaney Billboard promoting 2021 'Ipswich Festivals' initiatives;
    - Erection of (existing) street banners along Brisbane Road to promote the event;
    - Support from two staff from the City Events team during event delivery.

- B. Event Sponsorships under \$15,000 ex GST approved by the General Manager, Community, Culture and Economic Development:
  - 1. Rocky Trail Entertainment Limited \$3,500 annually for 3 years total \$10,500 ex GST for the Rocky Trail Fox Superflow Ipswich Enduro.
  - 2. Softball Queensland \$10,000 ex GST for the Softball Australia National U23 Men and U23 Women Championships.
  - 3. Ipswich District Teacher-Librarian Network \$14,437.50 combined cash and in-kind support for the StoryArts Festival as follows:
    - \$6,000.00 ex GST financial support (venue fees and family performance fees)
    - \$6,437.50 incl GST in-kind support (waiving of Ipswich Civic Centre venue hire)
    - \$2,000.00 in-kind support (two page feature in Council's quarterly guide)
- C. That council note that there were no event sponsorship related ticket allocations made to Councillors or council staff during this period.

# 6. <u>COMMUNITY FUNDING AND SUPPORT ALLOCATIONS STATUS REPORT 1 JULY 2020</u> <u>TO 29 MARCH 2021</u>

This is a report concerning the year-to-date allocation of Council's Community Funding and Support Programs from 1 July 2020 to 29 March 2021.

In the 2020-2021 financial year Council allocated a total \$1,751,448 to support the Ipswich community through the Community Funding and Support Programs including special COVID-19 Recovery Funding.

As at 29 March 2021 Council had allocated approximately \$932,661.47 to around 160 Ipswich community groups, sporting organisations and small businesses.

There is approximately \$818,786.53 in funding remaining across the Community Funding and Support Programs for the remaining three months of the 2020-2021 financial year – primarily in the Community COVID-19 Recovery Support Program, COVID-19 Ipswich Small Business Funding Program and the Councillor Discretionary Funds Program.

All successful applicants and projects are detailed in Attachment 1 and also reported online at <u>www.ipswich.qld.gov.au/services/funding-and-support</u> in accordance with Council's principles of transparency and the Community Funding and Support Policy

#### **EXECUTIVE SUMMARY**

This is a report concerning the procurement of the ongoing supply of physical library collection resources including print and audio-visual resources, and the relevant processing required for shelf-readiness of library collection resources for all Ipswich Libraries under Local Buy Pre-Qualified Supplier arrangement 'Library Resources (Goods and Services) LB284'.

The report recommends that pursuant to section 234 of the *Local Government Regulation* 2012 (Regulation), Council utilise LGA Arrangement "Library Resources (Goods and Services) LB284" by Local Buy Pty Ltd for the provision of physical library collection resources (Council reference 15900), with James Bennett Pty Limited (Supplier) who is a party to the LGA Arrangement.

#### PURPOSE OF REPORT/BACKGROUND

Ipswich Libraries provides exciting, innovative and immersive spaces and resources for community members of all ages. The Ipswich community is diverse and the library's collection profiles have been developed with the aim of creating comprehensive and balanced content for all.

Ipswich Libraries requires a supplier to provide the most up to date titles and new releases to regularly replenish the physical collection in accordance with the various library collection profiles. It also requires supply in response to ad hoc requests or special buys.

Council has engaged under previous LGA arrangements for the provision of library collection resources. Council released Request for Quote (RFQ) RFQ15900 on Monday 15 February 2021, via Vendor Panel to all Pre-Qualified Suppliers on the new LGA arrangement "Library Resources (Goods and Services) LB284". The RFQ closed on Tuesday 23 February 2021. In total 36 suppliers were notified of the RFQ and 12 suppliers responded to the RFQ.

The Evaluation Panel undertook an evaluation of the submissions and recommends James Bennett Pty Limited as the preferred supplier for the provision of the physical library collection resources, including print and audio-visual resources, in accordance with Confidential Attachment 1: 15900 Recommendation to Award.

The Evaluation Panel considered James Bennett Pty Limited demonstrated the best value for money for Council by offering a significant discount and rebate structure, having the necessary experience in supplying library collection profile orders to libraries across Australia and committing to exceed the level of service and key performance indicators specified in the LGA Arrangement.

Unfortunately, there are no companies local to the Ipswich City Council region capable of providing the required goods or services, with only one of the respondents based in Queensland. The supply of the goods or services does not require the use of local subcontractors, with no respondents subcontracting any part of the required services.

This report and its recommendations are consistent with the following legislative provisions: Local Government Act 2009 Local Government Regulation 2012

#### **RISK MANAGEMENT IMPLICATIONS**

The risk management implications have been considered in confidential Attachment 1.

#### FINANCIAL/RESOURCE IMPLICATIONS

The cost of the engagement for the provision and processing of physical library collection resources is estimated to be \$1,245,500 (ex GST) per annum, or \$4,982,000 (ex GST) for the contract term, including options. This estimate is based on current spend and anticipated future budgets and resource requirements.

There is no minimum spend requirement under this agreement and no exclusive right for the supplier to supply to the products, allowing Council to use multiple suppliers or change to an alternative supplier at any time.

#### COMMUNITY AND OTHER CONSULTATION

The Libraries and Customer Services branch have been consulted and have endorsed the Recommendation to Award.

There was no community consultation in the preparation of this report.

#### CONCLUSION

To ensure continued supply of the physical collection of the Ipswich Libraries collection profiles, it is recommended that Council utilise section 234 of the *Local Government Regulation 2012* and engage James Bennett Pty Limited under LGA Arrangement "Library Resources (Goods and Services) LB284".

#### **EXECUTIVE SUMMARY**

This is a report addressing the request by Council concerning the further investigation by Council officers into a non-exclusive arrangement with Playgroup Queensland and additional uses for the facility at 56 Harold Summervilles Road, Karalee described as Lease D in Lot 1 on RP170788 on SP216939.

#### **RECOMMENDATION/S**

- A. That Council receive and note the contents of this report.
- B. That Council enter into a Lease with Playgroup Queensland Ltd as per the recommendations from the report presented at the Governance and Transparency Committee No. 2020(03) dated 15 October, 2020 as outlined Recommendations C, D and E below:
- C. That Council resolve pursuant to the *Local Government Regulation 2012* (the Regulation) that the exception under sections 236(1)(b)(ii) and 236(2) of the Regulation apply to the disposal of the leasehold interest located over part of 56 Harold Summervilles Road, Karalee described as Lease D on Lot 1 on RP170788 on SP216939 ("the land"), by way of a lease between Council and Playgroup Queensland Ltd for a consideration.
- D. That Council enter into a Lease with Playgroup Queensland Ltd ("the lessee") for a five (5) year term.
- E. That under s257 of the *Local Government Act 2009*, Council resolve to delegate the power to the Chief Executive Officer to authorise and negotiate the terms of the Lease to be executed by Council with Playgroup Queensland Ltd and to do any other acts necessary to implement Council's decision.

#### PURPOSE OF REPORT/BACKGROUND

The previous report titled Renewal of Lease to Playgroup Queensland Ltd over 56 Harold Summervilles Road, Karalee was presented at the Governance and Transparency Committee No. 2020(03) dated 15 October, 2020 (Attachment 2). An alternate motion was proposed and seconded requesting that Council officers investigate a non-exclusive arrangement with Playgroup Queensland and additional uses for the facility at 56 Harold Summervilles Road, Karalee described as Lease D in Lot 1 on RP170788 on SP216939.

The Manager, Community and Cultural Services and the Community Development Manager attended an onsite visit to meet with representatives of Playgroup Queensland to complete an inspection of the facility. This provided an opportunity to better understand their program delivery and mix of activities as well as assisting Council in determining the potential for additional uses and activation of the facility by other groups.

Playgroup Queensland currently activate the facility two (2) days each week and are developing additional program content to validate a third day. Activation is restricted to School Term dates only.

The site inspection confirmed the following:

- The total lease area sits on 1822 square metres, comprised of one (1) secured building facility, two (2) shade structures, an amenities block and two (2) storage sheds;
- The secured facility provides for internal floor area of 120 square metres, inclusive of kitchen and storage space, leaving approximately 70 square metres for activities;
- Balance of leased area is grassed and gently sloping in a north westerly direction;
- External lighting is poor, potentially limiting any evening based activation;
- Public transport access is limited with nearest main intersection located 750m away; and
- The venue is currently not compliant with DDA requirements.

A further site inspection was conducted by the Division 4 Councillors and the Community, Cultural and Economic Development (CCED) General Manager to familiarise themselves with the facility.

Upon review it is the opinion of the General Manager CCED and Manager Community and Cultural Services that the facility is not practically suitable for multiple users.

This report and its recommendations are consistent with the following legislative provisions:




# **PROPERTY PLAN** 56 HAROLD SUMMERVILLES ROAD, KARALEE (LEASE D)

#### PURPOSE OF REPORT/BACKGROUND

In 2008, PQL approached Council expressing an interest in leasing the Rob Thompson Hall ("the Hall") located at 56 Harold Summervilles Road, Karalee ("the Freehold Land") to expand their services to Ipswich families. It was resolved by Council that the PQL provides the best opportunity for the future use of the Hall.

PQL is a not-for-profit organisation and peak body for playgroups in the State, and acts as a voice and advocates to the government and the wider community for families who represent playgroups.

There are several different types of playgroups including Community, Supported, Specialist and Therapeutic. PQL's Karalee Playgroup is classed as a Community type playgroup which offers a wide range of resources for babies, toddlers and pre-schoolers and is led by the parents.

PQL is a playgroup that offers early years' programs and services from 0-5 years of age to assist in achieving optimal child well-being and development. This is gained by learning through play, building parenting skills and connecting families to create a strong and sustainable community. Karalee Playgroup is a dedicated playgroup centre set up with reading corners, craft areas and the like. Outdoor includes a play area with bikes, cars, sandpit and swings. Fees are charged at \$3 per session.

PQL provides a much-needed platform for families to build lifelong friendships with parents and carers to support each other by sharing triumphs and challenges. Playgroups provide an environment for children to learn new skills required for their future.

The above proposed terms are subject to change.

In 2015, Council carried out an audit of its leases and specifically the rent charged. A delegated decision was made that all leases with a rental fee of \$104.00 or less would be charged on a demand basis in Council's commitment to sound financial management as the cost to Council to invoice, receipt and manage this money greatly outweighed the value of rent received.

In 2019, Council adopted the Tenure over Council Property Policy incorporating a new framework for the schedule of fees for different types of agreements. Council determine the category of a lease based on the use of the property by the community group/organisation and which category they fall under.

The existing lease between Council and PQL is currently operating under a 'holding over' provision on a month to month basis. It is recommended that Council enter into a new lease under the terms set out above, to ensure that Council complies with its obligations under its Tenure over Council Property Policy and any Regulatory Authority.

#### LEGAL/POLICY BASIS

This report and its recommendations are consistent with the following legislative provisions:

Land Title Act 1994 Local Government Act 2009 Local Government Regulation 2012

#### **RISK MANAGEMENT IMPLICATIONS**

There are low risk management implications pertaining to this lease as PQL are currently under a 'holding over' provision of the existing lease arrangement with Council. Council's new lease agreement clearly sets out the Lessor's (Council) and Lessee's (PQL) maintenance responsibilities.

#### FINANCIAL/RESOURCE IMPLICATIONS

Council is responsible for reasonable wear and tear of the premises. Council will continue its responsibility to carry out repairs, renovations, maintenance or alterations to the premises. Upon termination of the existing or new lease the lessee must return the premises to Council in good repair and working order, with the exception of reasonable wear and tear.

Council don't track the expenses for specific buildings. There is also no budget particularly assigned to specific parks and other facilities, however there is a budget for Parks in general.

As the renewal, upgrade, maintenance and operating expenditure relating to the buildings are not specifically catalogued to that building, it is unknown as to the historical cost and performance of that building and whether it is an efficient and sustainable asset for Council.

Council does not currently have a long-term financial forecast for its managed facilities. Long-term financial forecasting includes estimated capital expenditure for renewing, upgrading and extending each building and facility asset.

Under the *Local Government Act 2009* it is mandatory for Council to have a long-term asset management plan (AMP) and a long-term financial forecast.

Council currently has a very high level AMP lacking detail. The development of a more informed AMP for buildings and facilities, including long-term forecasting of those will ensure decisions are informed and will optimise asset performance and value at both portfolio and individual facility level.

The Local Government Regulation 2012 sets out the requirements of the AMP:

- must be for 10 years or more;
- continues in force for the period stated in the plan unless a new AMP is adopted by Council;
- provide for strategies to ensure the sustainability of the management of assets outlined in Council's asset register and Council infrastructure;
- state the estimated capital expenditure for renewing, upgrading and extending assets for the period stated in the AMP;
- be consistent with, and part of the long-term financial forecast.

#### COMMUNITY AND OTHER CONSULTATION

Following Council's review of the existing agreement, Council consulted with PQL to enter into a further lease over the Freehold Land. PQL have indicated their desire to enter into a lease renewal and are agreeable to the proposed new lease terms.

Internal consultation pertaining to the Hall was completed and the following was articulated below:

- Asset Management provided their consent to the new lease terms and associated maintenance schedule and advised there have not been any significant repairs and maintenance, other than fair wear and tear where required.
- Community, Cultural and Economic Development provided their consent to the new lease terms and advised no reported issues with PQL in their activation and use of the facility. Safe City provided further advice on the security component of the Maintenance Schedule to ensure the Hall is secured, alarmed and patrolled as required by Council.

#### CONCLUSION

It is recommended that Council apply the exception under the *Local Government Regulation* 2012 to enter into a lease with a community organisation, without going to tender or auction. The new lease between Council and PQL over 56 Harold Summervilles Road, Karalee will outline maintenance responsibilities by Council and PQL.



#### EXECUTIVE SUMMARY

This is a report concerning the Major Community Event Sponsorship application by Ipswich Show Society for support of the Ipswich Show to be held in May 2021 at Ipswich Showgrounds.

The application is for a cash sponsorship of \$40,000 along with in-kind support through the provision of rubbish bins and removal and a range of council services.

#### RECOMMENDATION

That Ipswich Show Society receive \$35,000 ex GST cash support for the 2021 Ipswich Show.

#### **ADVANCE IPSWICH THEME**

#### PURPOSE OF REPORT/BACKGROUND

The Ipswich Show Society has submitted a Major Community Event Sponsorship application for the 2021 Ipswich Show to be held Friday, 14 May to Sunday, 16 May 2021.

Council has been requested to provide financial support of \$40,000 ex GST and additional inkind support including:

- Trimming of trees
- 100 x 240L general waste bins and 600 liners
- 1 x large waste compactor
- 1 x 20m3 cardboard bin
- Repair of any bitumen failures/pot holes on the Ipswich Showgrounds
- Repair to external gardens
- Changing of parking signs to disabled parking signs in Parker Avenue
- Provision of a horticulture display plus 130 x 200mm pot size Golden Palm plants for decoration around the pavilions
- Assistance with advertising of the Show

In 2018, 2019 and 2020 Council declined the request to provide additional in-kind support and instead increased the sponsorship by \$5,000 in 2018 to provide a total \$25,000 ex GST financial support to the Ipswich Show Society. The recommendation is for Council to be consistent in this approach in 2021.

Council has completed a panel assessment of the event against the Major Community Event Sponsorship criteria and determined that the Ipswich Show meets the required eligibility and will contribute to the following community outcomes:

- High level of community engagement through participation and attendance
- A platform for local community organisations, artists and performers
- Strengthened local business and community connection

Some additional points worth noting are:

- The Ipswich Show was first held in 1873
- It is one of the longest running community shows in Queensland
- Approximately 30,000 people are expected to attend over three (3) days

- The cost to run the Ipswich Show has increased generally and to meet COVID compliance
- In 2021 Council and the Ipswich Show Society will conduct the first official Event Impact Study to better assess the event's economic and social value

Promotional benefits to Council include:

- Main Arena signage
- Billboard signage on Warwick Road
- Logo inclusion on promotional material (print and digital advertising)
- Inclusion of advertising in exhibit schedules
- Website promotion and linking
- Naming rights to agreed events in the Ipswich Show program
- Opportunity for Mayor/Councillors to participate e.g. award presentations
- Location of Discover Ipswich activation trailer in a high pedestrian traffic area at the event
- Provision of trade space in Main Pavilion and a dedicated space for a council horticultural display and/or other council displays

The Ipswich Show Society has requested a significant increase in event sponsorship for the 2021 event due to general increases in security and cleaning costs and to ensure COVID compliance. These additional costs have been transparently presented and it is recommended that Council make a one-off additional contribution in 2021, to increase council's level of support to \$35,000 to assist with increases related to COVID compliance.

An assessment of the projected budget accompanying the application does indicate that a number of costs presented are broad estimates only and that Ipswich Show Society could implement cost saving measures in other areas to offset general increases in security and cleaning.

Given this increase related specifically to COVID, it is not recommended that Council enter into a multi-year agreement and any future sponsorship application should be reviewed noting the 2021 increase was related to COVID.

# **LEGAL/POLICY BASIS**

This report and its recommendations are consistent with the following legislative provisions: *Local Government Act 2009* 

Section 109 of the *Local Government Act 2009* provides local governments with the ability to use discretionary funds in accordance with the requirements prescribed under the *Local Government Regulation 2012*.

Section 202 of the *Local Government Regulation 2012* prescribes a number of requirements for a local government making discretionary funds available.

There is a risk that the event may be postponed or cancelled due to the ongoing uncertainly around COVID. City Events will liaise closely with Ipswich Show Society on COVID Safe Event planning and adaption to minimise this risk.

If Council decided not to support Ipswich Show the event would proceed but would need to be scaled back accordingly.

#### FINANCIAL/RESOURCE IMPLICATIONS

The outlined support will be covered by dedicated event sponsorship funding allocated within the 2020-2021 City Events budget.

## COMMUNITY AND OTHER CONSULTATION

Pre-lodgement meetings have been held with representatives from Ipswich Show Society prior to the submission of the event sponsorship application.

Follow up discussions were held after receiving the application to clarify a number of aspects and to reinforce that council has an annual budget for Major Community Event Sponsorship set well in advance.

# CONCLUSION

Council has been requested to provide financial support of \$40,000 ex GST and additional inkind support.

In 2018, 2019 and 2020 Council declined the request to provide additional in-kind support and instead increased the sponsorship by \$5,000 in 2018 to provide a total \$25,000 ex GST financial support to the Ipswich Show Society. The recommendation is for Council to be consistent in this approach in 2021.

It is recommended that Council make a one-off additional contribution in 2021, to increase Council's level of support to \$35,000 to assist with COVID related costs.

Given this increase related specifically to COVID, it is not recommended that Council enter into a multi-year agreement and any future sponsorship application should be reviewed noting the 2021 increase was related to COVID.

#### **EXECUTIVE SUMMARY**

This is a report concerning the year-to-date allocation of Council's Community Funding and Support Programs from 1 July 2020 to 29 March 2021.

In the 2020-2021 financial year Council allocated a total \$1,751,448 to support the Ipswich community through the Community Funding and Support Programs including special COVID-19 Recovery Funding.

As at 29 March 2021 Council had allocated approximately \$932,661.47 to around 160 Ipswich community groups, sporting organisations and small businesses.

There is approximately \$818,786.53 in funding remaining across the Community Funding and Support Programs for the remaining three months of the 2020-2021 financial year – primarily in the Community COVID-19 Recovery Support Program, COVID-19 Ipswich Small Business Funding Program and the Councillor Discretionary Funds Program.

All successful applicants and projects are detailed in Attachment 1 and also reported online at <u>www.ipswich.qld.gov.au/services/funding-and-support</u> in accordance with Council's principles of transparency and the Community Funding and Support Policy.
