This is a report concerning the Discover Flavours of Ipswich Pilot Program run from Wednesday 7 to Saturday 24 April 2021 at a cost of \$60,000.

Discover Flavours of Ipswich was designed to support local hospitality operators whilst promoting Ipswich and its fare to Ipswich and Brisbane markets.

The program period saw an additional \$428,256 in sales for participating businesses compared to 2019 and generated \$322,144 in earned media value.

EXECUTIVE SUMMARY

This is a report concerning Ipswich City Council's Small Business Funding Program. The program was implemented in 2020-2021 to enable local business to recover from the impacts of COVID-19 and was a significant success, distributing a total of \$264,147.54 to 195 businesses.

In 2021-2022 a further \$150,000 has been allocated to support local small businesses. This report outlines the proposed principles for the funding program and requests Council endorsement to structure the program to build resilience and scale growth.

RECOMMENDATION/S

That Council endorse the proposed 2021-22 funding program principles outlined in this report as 'Building Resilience' and 'Scaling Growth'.

Strengthening our local economy and building prosperity iFuture theme: Vibrant and Growing

PURPOSE OF REPORT/BACKGROUND

Council introduced the Small Business Funding Program in the budget of 2020-2021 to support local small business recover from the detrimental effects of COVID-19. During 2020-2021 a total of \$264,147.54 was distributed to 195 businesses in small business funding. This funding has been used to support and rebuild many businesses in the COVID environment.

The most common expenses the funding was put towards was:

- Perishable stock replacement
- Obtaining professional advice from service providers like accountants

Sebastian Brun, owner of La Parilla Restaurant and Food Truck said:

"The Small Business Funding helped my business buy stock and allowed me to keep trading. I appreciate what Ipswich City Council have done to support my business."

Another recipient, NY Dance, a local dance studio, used the Small Business Funding to offset the cost of an advertising program. As a result of that campaign, NY Dance gained more dancers on their books than pre-COVID shutdown. As quoted in an Ipswich First article on 28 May, 2021, titled 'Local dance school emerges from pandemic stronger', NY Dance owner Natalie Yates said "What I learned was that through adversity it created opportunities for me and forced me to question what it is I need to do to keep my business alive. I took baby steps and did what I had to do to get through."

In the 2021-2022 budget, council is supporting local small businesses with another \$150,000 allocated to small business funding. As economic conditions settle into a new status-quo in a post-COVID environment it's important the new round of funding moves from a focus on recovery and is structured to encourage and enable Ipswich small businesses to increase their resilience, grow and in doing so, strengthen our local economy.

It is proposed to structure the 2021-2022 Small Business Funding Program along the following principles:

- Building Resilience through skill acquisition and execution
- Scaling Growth

Building Resilience

Ms Yates, from NY Dance (above), demonstrates the value of being supported through adversity to capitalise on opportunities.

The new funding program can increase similar impact by pairing funding with existing skill and capability programming being run by Council, the local Chambers of Commerce and other providers. What is often missing though in skill development programs is the funding required to implement new skills. For example, a marketing workshop will teach a business owner what's possible, but a lack of cashflow prevents that business owner from implementing the new skills.

The local business and investment team will work in conjunction with key stakeholders to develop funding program guidelines that maximise the impact of capability building programs by augmenting those programs with funding for implementation.

Scaling Growth

As businesses grow and scale, they experience new challenges; beyond foundational skills and more how to navigate and manage the complexity of implementing organisational structures and new supervisory layers, HR and industrial relations matters, not to mention finding and expanding into new premises.

To support Ipswich businesses that are ready to scale; say from 10 employees to 20; or 15 to 50 or more; the economic development team will design a funding program that helps businesses navigate these new complexities and successfully scale. This in turn will create more local job in already viable and resilient Ipswich businesses.

LEGAL/POLICY BASIS

This report and its recommendations are consistent with the following legislative provisions: Local Government Act 2009

RISK MANAGEMENT IMPLICATIONS

The key risks in establishing the new guidelines for the 2021-2022 Small Business Funding Program are to ensure funding is distributed in a way that is:

- Fair, equitable and transparent
- Encouraging desired behaviour and outcomes
- Complementary (and not duplicating) other funding programs offered by other levels of government
- Manageable by council and desirable by the local business community

These risks will be considered and managed as the economic development team work on the guidelines for the funding program.

HUMAN RIGHTS IMPLICATIONS

Section 58(1) of the Human Rights Act 2019 makes it unlawful for council to act or make a decision:

- (a) in a way that is not compatible with human rights; or
- (b) in making a decision, to fail to give proper consideration to a human right relevant to the decision.

As the funding program guidelines are developed the suitable human rights will be considered and the policy and guidelines developed to be compatible with Human Rights. For the purposes of this report, a Human Rights assessment is considered premature and therefore has not been completed.

FINANCIAL/RESOURCE IMPLICATIONS

A total of \$150,000 has been allocated in the 2021-2022 budget for small business funding. It is intended that 100% of this amount is distributed to local businesses to build resilience and scale-up. Administrative, marketing, labour and other associated costs will be managed from the economic development section of the budget.

COMMUNITY AND OTHER CONSULTATION

Preliminary consultation has taken place with the Economic and Industry Development Chair Councillor Jonic as well as the Presidents of Ipswich and Region and Greater Springfield Chambers of Commerce. Further consultation will take place in the design of the funding program guidelines.

CONCLUSION

As Queensland continues to navigate a 'new-normal' in a post-COVID environment, it's important that Council's Small Business Funding Program moves beyond recovery and enables local business to build resilience and scale-up, strengthening the local economy and creating local jobs. It is therefore recommended that the guidelines for the small businesses funding program are structured accordingly.
