#### **EXECUTIVE SUMMARY**

This is a report concerning the establishment of a large-sized contractual arrangement following an Open Tender process for the Parks and Facilities, Flood Damaged Assets Reconstruction Project for an approximate purchase price of \$6,089,711.75 (excluding GST). H & G Contractors Pty Ltd are a local business and have nominated local suppliers that will support them in the delivery of the project, H & G Contractors Pty Ltd were identified as a local supplier through the Buy Ipswich Approach.

- B. That Council enter into a contractual arrangement with the Supplier at an approximate purchase price of \$6,089,711.75 excluding GST.
- C. That pursuant to Section 257(1)(b) of the *Local Government Act 2009*, Council resolve to delegate to the Chief Executive Officer the power to take "contractual action" pursuant to section 238 of the Regulation, in order to implement Council's decision.

## **PURPOSE OF REPORT/BACKGROUND**

The purpose of this document is to seek approval to establish a large-sized contractual arrangement with the recommended Supplier to deliver the Parks and Facilities – Flood Damaged Assets Reconstruction Project while providing detail of the procurement process to arrive at the recommendation.

Council released a Tender to the open market via Vendor Panel (VP340369) on 14 December 2022 and 27 January 2023. The Tender process was administered by Council's Procurement Branch.

#### **LEGAL IMPLICATIONS**

This report and its recommendations are consistent with the following legislative provisions: *Local Government Regulation 2012* 

#### **POLICY IMPLICATIONS**

The matter of this report is consistent with the Procurement Policy. No other policies have been identified that would be impacted.

#### **RISK MANAGEMENT IMPLICATIONS**

Should the recommendation not be adopted by Council then the reconstruction of community and recreational assets will be delayed, and risk not being completed in accordance with the Queensland Reconstruction Authority (QRA) key delivery dates. All community and recreational asset works must be completed by 30 June 2024.

### FINANCIAL/RESOURCE IMPLICATIONS

In accordance with Council's Disaster Recovery Funding Arrangement (DRFA), the expressions of interest identifying work projects to QRA was required by 31 July 2022 following the announcement of this funding to local authorities for community and recreational assets rehabilitation works.

Reconstruction of community and recreational assets will be funded by QRA. There may be a delay in receiving approval of funding by QRA which is anticipated at being post contract execution with H & G Contractors Pty Ltd.

This will require funding to be covered by Ipswich City Council until funding is received by QRA. Presently, Council has only received the initial provisional approval under the QRA EOI application process and final approval is yet to be granted. If QRA determines moderation and limited funding over some projects within the program Council may be required to fully fund those gaps.
