### PURPOSE OF REPORT/BACKGROUND

Council is committed to undertaking advocacy in a coordinated and planned manner to support regionally significant projects to secure long term social, economic and environmental benefits to the community of Ipswich.

iFuture incorporates the following as a catalyst project: Advocacy to State and Federal Governments for the city shaping initiatives including:

- Ipswich to Springfield Central Public Transport Corridor options analysis and business case
- Cunningham Highway (Yamanto to Ebenezer Creek upgrades)
- Ipswich Central Second River Crossing detailed business case

The 'We can't wait' campaign is an Ipswich City Council initiative that aims to advocate on behalf of Ipswich residents, the urgent need for investment in our roads and public transport, ahead of the State election in October 2024. As a voice for all residents,

businesses, communities and groups within Ipswich, the campaign calls for critical funding required for the following key projects:

- Delivery of a mass transit solution in the Ipswich to Springfield Central (I2S) Public Transport Corridor connecting Ipswich to Springfield Central via Ripley and Redbank Plains.
- Funds for critical upgrades to the Cunningham Highway (Yamanto to Ebenezer Creek section), including duplication and updates to the Amberley Interchange.
- Funds for a business case required to progress the Ipswich Central Second River Crossing.

# September Campaign Update

On the 20<sup>th</sup> of September 2024, the State LNP party made an election commitment for \$4 million towards the business case for the Ipswich Central Second River Crossing project.

Below a marketing and media update has been provided for the advocacy campaign covering the period from 1 to 23 September 2024.

# Marketing

- **Critical and Enabling Infrastructure** messaging "We can't wait for safer highways" wrapped up in August, with one remaining ad live in market this month:

- **Ipswich to Springfield Central (I2S) public transport corridor** messaging "We can't wait to get 68,000 cars off our roads" was live in market for the first half of the month (excluding train artwork which runs longer) across the following channels:
  - Billboards: Tulmur Place, Ipswich (1-22 Sep); Brisbane Rd, Bundamba and Bremer St, Ipswich (26 Aug - 22 Sep)
  - Facebook and Instagram (6 Sep 6 Oct)
  - o Radio: River 949 (26 Aug 22 Sep)
  - Shopalives: Digital retail panels in Riverlink, Booval Fair, Redbank Plaza and Orion (2-8 Sep)
  - EDM to all waitlist supporters (17 Sep)
  - Platform signage: Springfield Central train station (1 Jul 6 Oct)
- Ipswich Central Second River Crossing messaging "We can't wait for a second river crossing" is now live in market for the remaining two week of the campaign across:
  - o Billboards: 273 Brisbane St and Tulmur Place (23 Sep 6 Oct)
  - Radio: River 949 (23 Sep 4 Oct)
  - Facebook and Instagram (w/c 30 Sep)
  - Shopalives: Digital retail panels in Riverlink, Booval Fair, Redbank Plaza and Orion (30 Sep - 6 Oct)
- **Generic** campaign messaging "A voice for fairer funding in the city we love" that continue to be live in market:
  - Train station signage: Ipswich and Redbank stations (1 Jul 30 Sep)
  - Digital roadside ads (1 Jul 30 Sep)
  - Posters and flyers in local businesses across Ipswich, Springfield and Rosewood (w/c 15 Jul to w/c 23 Sep)

- Website: The campaign website has received 7,513 visits since the initial launch (1 Jul - 23 Sep)
- Wait list registrations: 1,339 people have registered their support (as at 8.30 am, 23 Sep)

### PURPOSE OF REPORT/BACKGROUND

Officers have invited Blight Rayner to provide a briefing to the Advocacy Advisory Committee members of the work in progress in relation to the North Ipswich Sport and Entertainment Precinct Western Grandstand project. The current version of the preliminary concept design is provided in confidential attachment 1. A summary of the work to date is provided below.

# **General Project Overview**

Option 1 from the business case provides a grandstand that could typically hold state and local level sporting competition games as well as be scaled up to host one-off premium sporting, recreational, cultural and entertainment events with a minimal outlay to achieve increased capacity and would also be a more attractive regional setting than the existing facility.

An overview of the scope of works and preliminary concept design is provided in attachment 1.

#### **Procurement Process**

Following an open market tender process seeking a lead architect to deliver and project manage the delivery of the scope of works there were ten compliant submissions received from a range of regional, national and international architectural firms. Council has selected engaged Blight Rayner to deliver the scope of works for the project.

Blight Rayner most recently delivered the design for the National Rugby Training Centre at Ballymore – which included a new 3000 seat grandstand, training centre, corporate centre and administration facilities. Other projects they have delivered designs for include the Sunshine Coast Stadium, Logan Indoor Sports Stadium and the Griffith University Nathan Campus Sport Centre Precinct.

## **Concept Design**

Since being engaged, Council officers have been working closely with Blight Rayner to commence the design development process and to spatially locate the core components of the project within a new western grandstand on site.

In terms of the approach, the majority of the core components that ensure sporting code compliance is achieved are housed in the ground floor of the new western grandstand. In addition to these core components, public amenities and a new food and beverage concessionaire outlet have also been included on this level. The current design proposes the North Ipswich Reserve Corporate Centre function rooms are re-purposed for a gymnasium and administration area for the Ipswich Jets. The view of the playing surface from the existing corporate centre would be obscured by the new grandstand so re-purposing this area for a gym is considered a pragmatic and cost-effective solution for this space.

There was support from the Advocacy Advisory Committee for the existing oval configuration to be reconfigured to a rectangle which would enable spectator experience to be improved by being closer to the field of play.

On the first level of the proposed grandstand structure, new function rooms and corporate suites are proposed to replace the existing function rooms in the corporate centre. We have also incorporated coach's boxes, timekeepers room, amenities and a finishing kitchen. A terrace is also proposed on this level.

The existing corporate centre commercial kitchen is to be retained by Council to service the corporate facilities within the grandstand. The new finishing kitchen will allow for food prepared in the corporate centre kitchen to be "re-generated" and finished prior to serving in the function space/corporate suites.

These drawings will be used to form the basis of stakeholder engagement, further design development, cost planning and site due diligence.

It should be noted that lighting is not yet shown on the drawings provided.

# FINANCIAL/RESOURCE IMPLICATIONS

The North Ipswich Sport and Entertainment Precinct – Stage 1 Western Grandstand project is being funded from the federal government's Priority Community Infrastructure grant funding program. Council executed a funding agreement in March 2024 for an initial amount of \$500,000 out of the \$20 million election commitment. The balance \$19.5 million will be made available for project delivery subject to the outcomes of the design and due diligence phase.

There will be \$39.5 million in total remaining from all three levels of government for project delivery:

Federal government: \$19.5 million
State government: \$10 million
Ipswich City Council: \$10 million

#### COMMUNITY AND OTHER CONSULTATION

Consultation has been undertaken with the following stakeholders:

- The Honourable Shayne Neumann MP, Federal Member for Blair
- Ipswich Jets stakeholders including, Steven Johnson (Chairman), Richard Hughes (CEO) and Blake Mara (Pathways, Operations and Community Manager).

The Hon. Neumann MP outlined support for the concept design noting that it met his expectations for the project. The Hon. Mr Neumann MP requested consideration be given to broadcast standard lighting and a replay screen being delivered within the budget.

Ipswich Jets stakeholders provided feedback regarding the operational aspects of the layout, and we have made some minor amendments to the dressing room configuration and the location of medical and drug testing rooms to address this feedback. Ipswich Jets are supportive of the use of the corporate centre as a gym.

Further engagement will be undertaken with sporting organisations, education stakeholders, government stakeholders and event promoters as part of the design development phase.

### **CONCLUSION**

In the period since the execution of the funding agreement, Council have successfully procured and engaged architectural and project consultancy services and engaged with key stakeholders in order to advance the design development process for the North Ipswich Sport and Entertainment Precinct – Stage 1 Western Grandstand.
