EXECUTIVE SUMMARY

This is a monthly report by the Chief Executive Officer focusing on a summary of organisational performance in the areas of workplace health and safety, progress in the delivery of Council's Corporate and Annual Plans, our people and culture, financial management, capital program delivery, external funding, significant risks and legal matters.

This report is for the month of March 2026. The report for this period highlights current significant matters and progress on key performance indicators.

BACKGROUND

1. Current Significant Matters

Redbank Plaza Library Opening

Redbank Plaza Library has reopened after a comprehensive refurbishment, delivering expanded space and new features to improve access, comfort and functionality for a growing community. The upgrade includes a redesigned children's area with bespoke shelving, a digital access station for carers, additional study spaces, and improved public computers and printing. Modern reading areas and a streamlined book marketplace enhance usability for families, students, older residents and casual visitors. The library has resumed its full program of services, events and workshops, supporting strong visitation and reinforcing its role as a valued, future-focused community hub.

New exhibition showcasing one of Australia's most significant living artist

A major retrospective of one of Australia's most significant living artists, Leonard Brown, is being presented at Ipswich Art Gallery, marking a major cultural milestone for the city. Spanning more than five decades of minimal abstract painting, the exhibition draws together works from major national public and private collections, offering a rare insight into a nationally acclaimed practice grounded in Ipswich. The gallery will be transformed into a contemplative, immersive environment. Attracting more than 100,000 visitors annually, the gallery is one of Australia's most visited regional venues, and the exhibition is expected to

draw audiences from across Queensland and beyond. The exhibition runs from late March to mid-June 2026, with a temporary closure prior to opening for installation.

Ipswich showcases its best for 2026 visitors

Ipswich City Council has released the 2026 Ipswich Visitor Guide, highlighting the city's diverse tourism experiences, events and local character. The guide features family-friendly attractions, dog-inclusive experiences, artisan producers, adventure activities and relaxing accommodation options, alongside quirky dining, self-guided journeys and Ipswich Trails App experiences. Practical planning tools include maps, a business directory and a major events calendar showcasing nationally significant festivals held throughout the year. Distributed across southeast Queensland, Queensland and northern New South Wales, and promoted through digital and outdoor channels, the guide supports a tourism sector that attracts around two million visitors annually and delivers strong economic benefits to the region.

WaterFest 2026

Ipswich's waterways are being celebrated through WaterFest, a biennial program of free and low-cost activities running from March to May. Activities include fishing, canoeing, environmental workshops, guided nature walks, app-based family challenges and community planting, encouraging connection with local creeks and rivers while supporting healthier, more resilient waterways.

The Future Belongs to the Weird

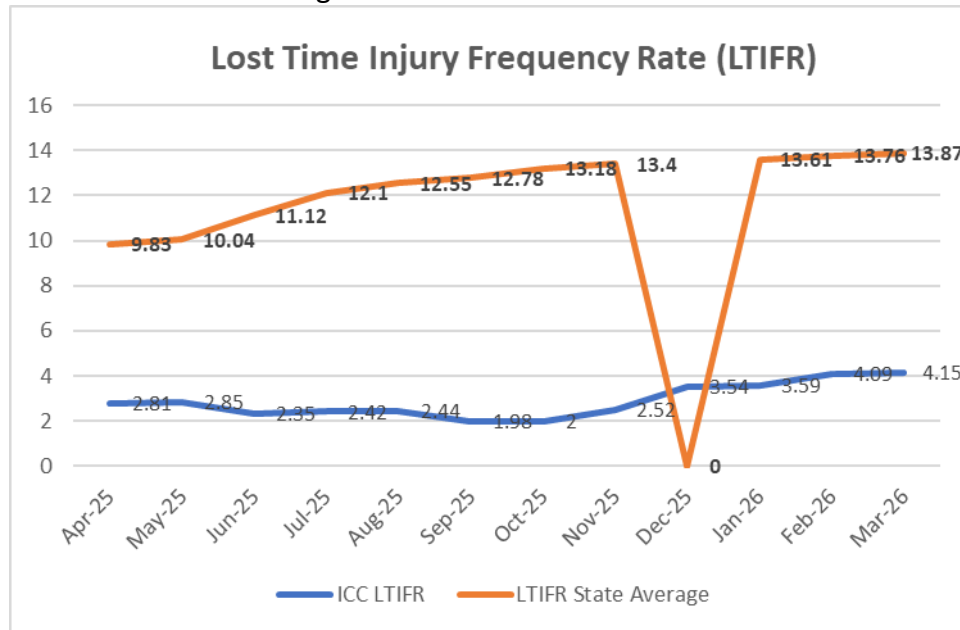
Creators' Summit Ipswich drew record attendance to the Ipswich Civic Centre, bringing artists and creatives from across southeast Queensland together for a day of learning, networking and inspiration. The program featured nationally recognised creatives alongside strong local talent through keynotes, workshops and collaborative sessions, highlighting both emerging and established voices. Highly regarded by participants, the event strengthened Ipswich's creative identity and momentum as a growing cultural hub.

Spanning from 1860 to the late nineteenth century, the records provide insight into the early decisions that shaped Ipswich's development. Plans are underway to digitise additional years, with community volunteers invited to help transcribe the handwritten documents and improve access to this valuable historical resource.

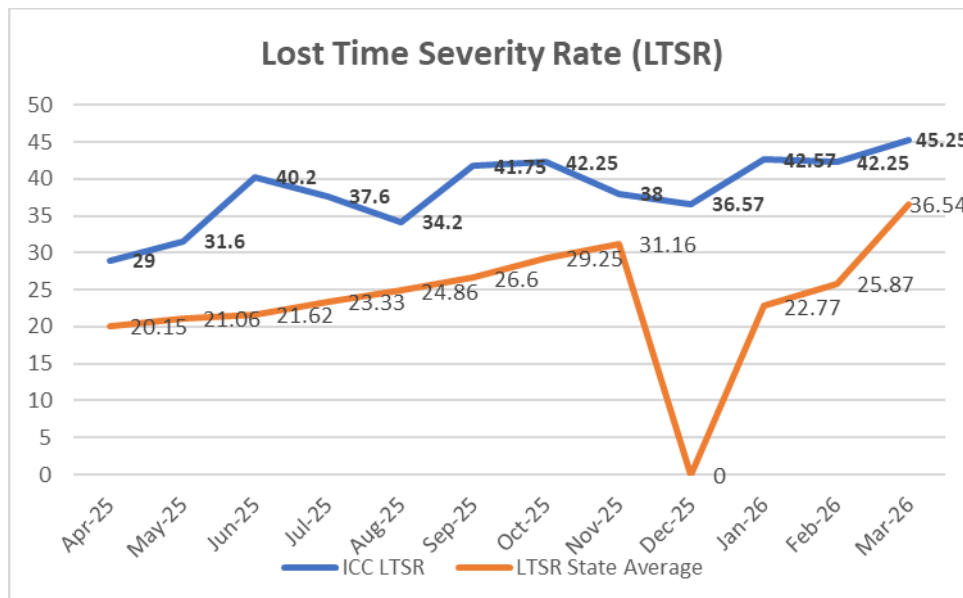

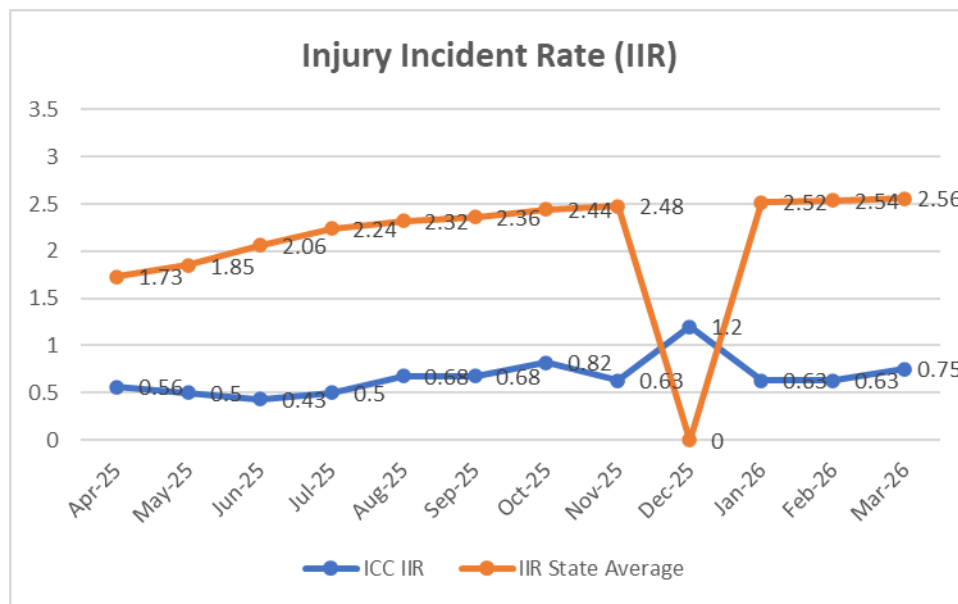

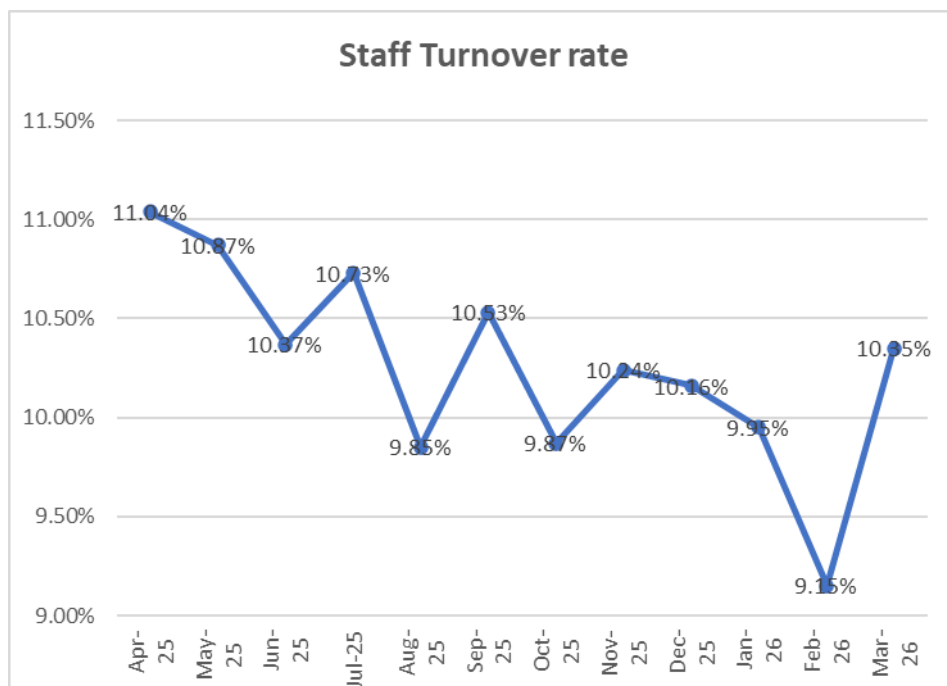
The new Corporate Plan 2026-2031 will be presented to the May 2026 Council Ordinary Meeting.

4. Major Key Performance Indicators

People and Culture



The total workforce for the council organisation ‘head count’ was 1598 in March 2026.



Staff turnover rate was at 10.35% in March 2026, up by 1.20% from February 2026.

For interest, but not direct comparison due to the time and calculation differential, the annual average workforce attrition rate for councils for 2025 reported by the LGAQ was around 18%.

Finance

The full financial performance report for March 2026 has been provided to the Finance and Governance Committee.

The total net result (including capital revenue) for Ipswich City Council as of 31 March 2026 is a surplus of \$119.0 million compared to the year to date (YTD) budget surplus of 111.5 million. Council's YTD operating surplus (excluding capital revenue and the Infrastructure Levy) is \$2.0 million compared to the budgeted YTD deficit of \$1.8 million. The favourable result is driven by higher interest income, greater Urban Utilities tax revenue, greater town planning and development fee revenue, and unbudgeted funding received from the Queensland Reconstruction Authority (QRA) relating to the Ex Tropical Cyclone Alfred event. This is partly offset by overspends on employee expenses and increased depreciation.

Capital expenditure (excluding asset donations and disaster recovery) is \$9.1 million below the YTD budget. Underspends were mainly due to the tenancy fit-out delays in Nicholas Street Precinct, timing of the North Ipswich Reserve Western Grandstand, and timing of fleet acquisitions. There were also savings on surfacing works at Redbank Plains Recreation Reserve car park. This is partially offset by overspends in asset rehabilitation, mainly due to timing of expenditure on the drainage rehabilitation on East Ipswich Stage 1 and Champions Way, earlier than planned works on softfall replacement programs due to contractor availability and unbudgeted works on John Williams and Henry Lawson Bicentennial Parks.

Capital Delivery Program 2025-2026

March 2026 actual expenditure of \$9.467 million, materially behind the \$12.431 million budget. While under budget, the result is reflective of project timing rather than a significant underspend.

5. Risk and Compliance Update

Corporate Risk Register

Council's corporate risk register is reviewed on a regular basis. Council's corporate risk register is scheduled for review at the ELT Risk Committee meeting scheduled for 14 April 2026.

Council's corporate risk register and risk trends in these risks are reported through Council's Audit and Risk Management Committee (ARMC) which is held every quarter. Council continues to seek to actively manage and mitigate its corporate risks.

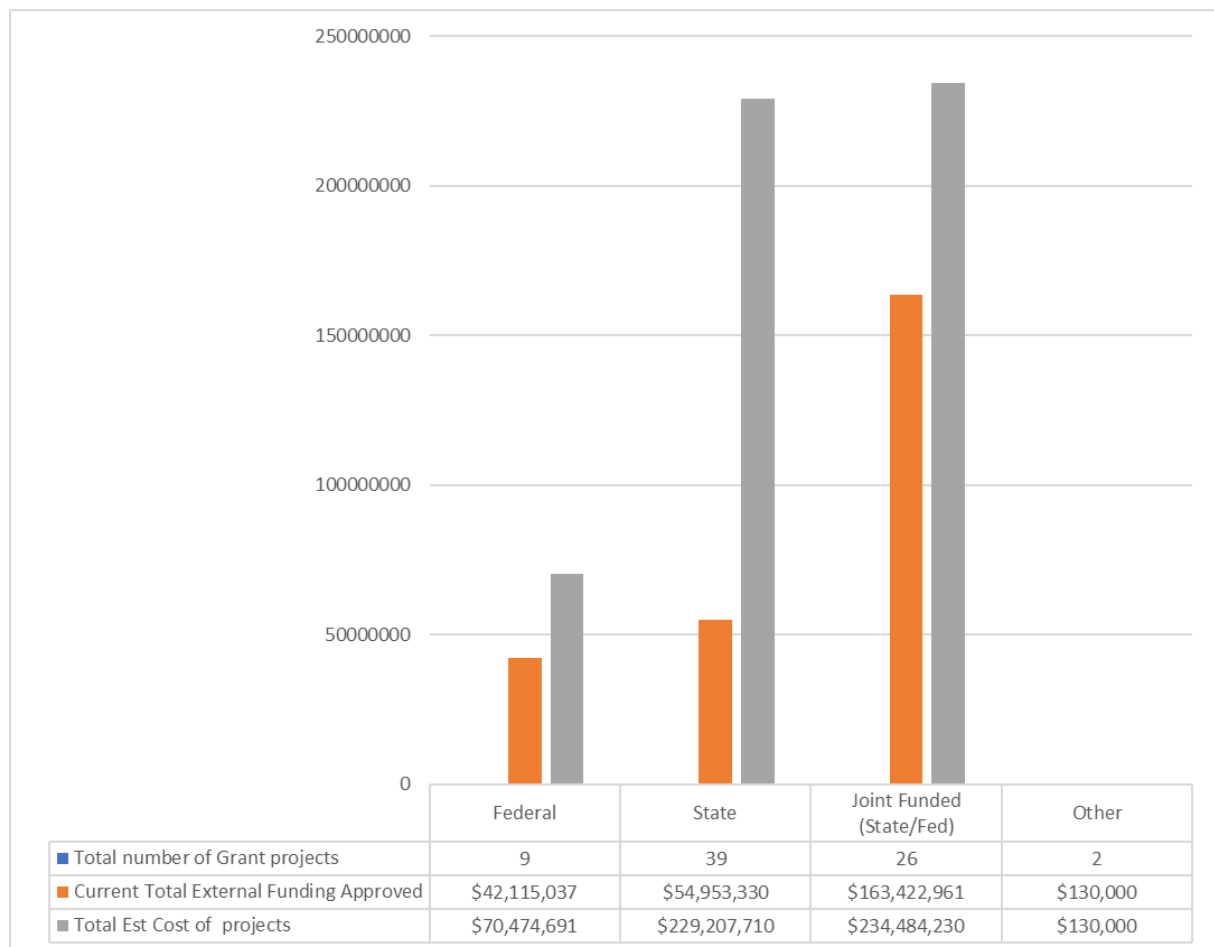

This is a notice of motion submitted by Councillor Jacob Madsen concerning e-mobility reforms.

Councillor Jacob Madsen gave notice of his intention to move the following motion at the Council Meeting of 30 April 2026:

MOTION

A. That Ipswich City Council:

1. Expresses concern that the State Government's proposed e-mobility legislation will remove viable transport options for Ipswich people during the fuel crisis and will have negative impacts on Council's long term active transport initiatives (namely the City of Ipswich Transport Strategy iGo).
2. Expresses concern that the proposed 10 km/hour speed limit for e-bikes on shared pathways will make hundreds of kilometres of shared paths in Ipswich which have been specifically built for bike riding no longer appropriate for e-bikes and other e-mobility solutions.
3. Expresses concern that long term planning for active transport in Ipswich will be negatively impacted, and Council could be exposed to costs in updating plans and strategies to due to the implication of the State Government's legislative changes.
4. Expresses concern that any updates or new signage required on shared pathways is a cost shift onto Local Government to implement the State's reforms, and this cost should be met by the State Government.

B. That the CEO write to the Minister for Transport and Main Roads to express the above concerns and request funding for implementation of any changes forced onto the Council as a result of the State Government's legislative reform.
